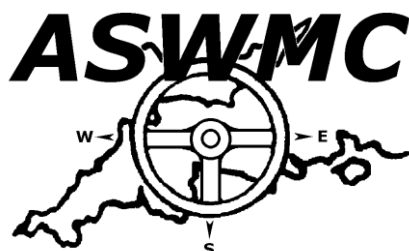

## **SUPPLEMENTARY REGULATIONS**

1. The Midland Automobile Club (Est. 1901) Limited will organise a Clubmans Permit Sporting Trial on Sunday 18<sup>th</sup> August 2024 at **Shelsley Walsh Hill Climb, Shelsley Walsh, Worcester, WR6 6RP**
2. The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.
3. Motorsport UK Permit Number : 133850
4. The event is open to all fully elected members of the following clubs:

5. This event is a round of the BTRDA Sporting Trials Championship
6. All competitors, drivers and passengers must produce a minimum Motorsport UK RS Clubman valid competition licence, club membership card and championship registration card (if applicable). Passengers must also carry a valid invited club membership card (Motorsport UK rule T3.1.6). BTRDA Trials Passenger cards will be accepted.
7. The programme of the meeting will be:  
 Signing-on and Scrutineering starts at 8.30am  
 Any competitor not signed on by 9.45am may be excluded  
 First car starts at 10.30am
8. Public roads will not be used to link sections.  
 There will be a minimum of eight sections on private land, each of which will be attempted three times (weather permitting).  
  
 Cars may be double driven.
9. The entry will be split into groups starting at different sections.
10. Practicing will not be permitted.
11. Competitors will be identified by number cards which will be issued by the organisers. A ballot will be drawn to determine the order of running prior to the event.
12. The Marshals at the event will be judges of fact.
13. Awards will be presented as follows:  
 1<sup>st</sup> in class awards will be presented on the day
14. The maximum entry for the meeting, including reserves, is 50. The minimum is 20.  
 Should the above minimum figure not be reached, the organisers have the right to cancel the meeting.  
 Entries will be taken in order of receipt up to the maximum.  
 Entry fees will be refunded to those withdrawing before the closing date, subject to a £5 administration fee.

15. The entry list opens on publication of these Supplementary Regulations and closes finally on **Monday 11th March 2023**. The entry fee is £60.00
16. All entries must be made on the official entry form and be accompanied by the appropriate fee. Entry fees will be banked as received. Entries cancelled 14 days or more prior to the meeting will be refunded in full less a £15.00 administration charge. Entries cancelled between 7 and 13 days prior to the meeting will be refunded in full less a £25.00 administration charge. Entries cancelled less than 7 days prior to the meeting may be refunded Motorsport UK per capita charges only, upon application to the Secretary of the Meeting.
17. Nomination of drivers and passengers as entry form when entered.
18. In the unfortunate situation of the cancellation of an event as a result of circumstance beyond our control, e.g force majeure, pandemic, dictates from Government and/or Motorsport UK etc. We will propose returning of event fees less actual costs, up to a maximum of £15.  
  
Postponement/Cancellation will be notified by email and via the MAC Website.
19. OFFICIALS: All officials will be notified in the final instructions.
20. Provisional results will be published as soon as possible after the event and by email.
21. Marking and penalties will be as printed in **Chapter 17 Appendix 2 Article 31** of the Motorsport UK General Regulations. All other General Regulations of the Motorsport UK apply as written except the following, which are modified:
22. The current BTRDA modified rule known as the '3 second rule' is adopted where there is a 3 second allowance for the competitor to regain forward motion. The marshal will count 'and 1 and 2 and 3'. With one exception, should a competitor stall the engine in a section this counts as a stop with no time allowance. The exception is, should the engine stall occur downhill and the car continues forward motion while the competitor restarts the engine, there is no penalty.
23. Any protest must be lodged in accordance with **Chapter 2 Appendix 9**.
24. All vehicles must comply with Motorsport UK Technical Regulations and with the National Trials Car Formula  
The event will consist of classes as follows:
  - a. Red Independent
  - b. Red Live Axle
  - c. Blue Independent
  - d. Blue Live Axle
  - e. Rookie
  - f. Post Historic (can run to their own regulations and can use any of the previous or current listed tyres in the Motorsport UK Yearbook).
  - g. Invitations Class (cars outside the BTRDA & Motorsport UK Championship Regulations. These cars will not be classified in the overall results for the day).
25. Permitted tyres for this event are - Nankang CX668, T-Trac 2,Maxxis MA-510N,.Yokohama Gt Special Classic  
  
Competitors may use any other tyre listed in the Motorsport UK Blue Book but will be excluded from the results.
26. From 01/01/2020 All cars must be fitted with a Red seal from the Sharp test.

27. A minimum tyre pressure will be applied on the day at the discretion of the clerk of the course. Checks may be carried out to confirm compliance. 12 penalty points will be applied for each breach of the rule.
28. No person may drive, or be a passenger in a competing car on the site unless they are the official signed on crew for that car.
29. The clerk of the course is responsible for the safe running of the trial. No marshal or competitor may change a section without the express permission of the clerk of the course.
