[1] Announcement

The Midland Automobile Club (Est. 1901) Limited will organise National and Interclub Status Speed events on the dates listed in Appendix A at Shelsley Walsh and Curborough.

[2] Jurisdiction

These meetings will be held under the National Competition Rules of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue.

[3] Permits

ASN Permit No(s): to be specified in Event Final Instructions.

[4] Eligibility

4.1. These events are open to all fully elected members of The Midland Automobile Club (Est. 1901) Limited and the Championships/Clubs listed in Appendix A for specific events.

4.2. National Status events are open to competitors registered in invited championships and members of invited clubs holding valid Motorsport UK Speed National, Race National or International Competition Licences.

4.3. Interclub Status events are open to competitors registered in invited championships and members of invited clubs holding as a minimum a valid Motorsport UK Interclub Licence.

4.4. Competitors from Overseas may compete in the meeting providing they can provide their ASN details to the Secretary of the Meeting before the event commencing.

4.5. Any driver competing in a Racing or Sports Libre car of more than 1100cc or equivalent forced induction, with the exception of a pre-1994 Formula Ford 1600 in compliance with the period Formula Ford Regulations, **must** hold an RS National or Race National licence **UNLESS** the vehicle is currently licenced for use on the Public Highway and competes at the event in a road legal condition.

4.6. Competitors may be asked to produce all relevant documentation.

4.7. A 15% random sample of all Competitors will be carried out; failure to produce the appropriate licence will result in a non-production fee as per NCR Ch.6 App.1 Art.12.2.

4.8. Classes are set out in Appendix B. All vehicles must comply with the NCR Technical Regulations.

[5] Championships

Invited Championships for each event can be found in Appendix A.

[6] Scrutineering

Scrutineering start time will be notified in the Event Final Instructions and will be completed as close to Class Order as possible, in the cars designated Paddock Space.

[7] Event Start

7.1. Practice will commence as per the Event Final Instructions.

7.2. For events with a Handicapping element, handicap times will be published by the Handicappers.

7.3. All signing-on must be completed electronically in advance of the meeting as paper copies will not be accepted.

7.4. Any competitor not signed on by 6pm on the Friday of the event weekend may be disqualified.

7.5. Please ensure that you bring with you the usual documents such as licence, club membership & championship registration cards etc.

[8] Description of Event

8.1. The Event format for each Event will be issued in the Event Final Instructions.

8.2. Event Final Instructions will be issued **no later than a week prior** to the Event.

8.3. Classes that apply for each Event can be found in Appendix B.

[9] Vehicles Starting Positions

Competitors will complete the course in as close to programme order as possible, or as amended by the Clerk of the Course or the Paddock Marshals.

[10] Practicing Requirements

10.1. Practice will be permitted.

10.2. The format of Practice will be published in the Event Final Instructions. Competitors are strongly recommended to walk the course up to 15 minutes before the start of Practice.

[11] Identification

11.1. Identification numbers will be notified as per the Event Entry List.

11.2. Numbers must be visible from each side of the Vehicle and displayed on a contrasting background in a proper and durable manner acceptable to the Chief Timekeeper at the Event as per NCR Ch14 App.2 Art.3.1.

11.3. For Shelsley Walsh events a third set of numbers which can be smaller **MUST** be displayed on the front left-hand side of the car to enable the timekeepers to identify cars approaching the start line.

11.4. When two drivers compete in the same car, two sets of suitable numbers must be provided by the entrant and changed as necessary. Cars will not be permitted to run with two sets of numbers displayed at the same time.

[12] Pits Area

12.1. **No** trailers, motorhomes or support vehicles will be allowed into the Shelsley paddock whilst the meeting is in progress.

12.2. At Curborough trailers, motorhomes or support vehicles can be parked on the grass before your designated paddock space.

[13] Judges of Fact

13.1. Judges of Fact will be present to determine whether a False Start has been made.

13.2. Any further Judges of Fact will be notified in the Event Final Instructions.

13.3. The Environmental Scrutineer will be the Judge of Fact in noise-related matters and may request additional testing of any car suspected of creating excessive noise.

[14] Television Coverage

Certain events may be streamed live. There are no advertising restrictions other than those listed in NCR Ch.6 App.1 Art.8.

[15] Awards

15.1. Awards will be presented as follows: -

First in each Class (subject to a minimum of 3 starters)

Second in each Class (subject to a minimum of 6 starters)

Third in each Class (subject to a minimum of 10 starters)

15.2. An Award will be presented for the Best Time of Day at all Shelsley Events.

[16] Entries

16.1. The maximum entry for each meeting is listed in Appendix A. The minimum is 100. Should any of the above figures not be reached, the organisers have the right to amalgamate classes or cancel the event.

16.2. All entries will be held in abeyance for consideration immediately after the closing date, and notification of acceptance or refusal will be emailed shortly after this date for each event. Competitors requiring confirmation of receipt of entries should contact the office.

16.3. Please note that, in the event of entries being oversubscribed, priority for entries will be as follows: -

Priority 1: Entrants in an invited championship who are members of the MAC

Priority 2: Entrants in an invited championship (who are not a member of the MAC)

Priority 3: MAC Members not in a championship

Priority 4: Members of an invited club

Priority 5: Any other entrant

16.4. At the Vintage Meeting priority will be given to both MAC and VSCC Members.

16.5. If the number of invited championship entrants exceeds the entries allocated to them either by the overall event limit or another limit imposed by the club, the championship coordinator will be invited to advise on the selection of successful entries. In the case of the meeting as a whole being oversubscribed, the club's selection committee will decide on the allocation of entries subject to the above.

[17] Entry List

17.1. The entry list opens on publication of these Supplementary Regulations and closes finally at midday on the dates for individual events as listed in Appendix A.

17.2. All entries must be made online via the Club's website <https://www.shelsleywalsh.com/hill-climbs-compete>. Multiple or single entries can be made.

17.3. Late entries may be accepted at the discretion of the organisers as long as the events are not over-subscribed, and subject to the payment of a late entry fee of £25.00.

[18] Entry Fee/Refunds

18.1. The Entry Fee is as follows: -

Shelsley Events

National: £205/ £190 MAC Member

Interclub: £165 / £150 MAC Member

Vintage Meeting: £165 (All Entries)

Curborough Events

Interclub: £160 / £145 MAC Member

18.2. Entries cancelled 14 days or more before the meeting will be refunded in full less a £25 administration charge.

18.3. Entries cancelled between 7 and 13 days before the meeting will be refunded in full less a £40 administration charge.

18.4. Entries cancelled less than 7 days before the meeting will receive a refund of £25 only, upon application to the Secretary of the Meeting.

18.5. Entries that are made incorrectly, resulting in the entry having to be refunded, will incur a £40 admin fee.

18.6. All refunds will be processed during the week following the event.

[19] Refusal of Entries

All entries are accepted or refused at the discretion of the Organisers. In the event of a refusal, the entry fee will be refunded IN FULL regardless of when the refusal is notified.

[20] Additional Entry Information

By entering an event all competitors and their associates commit to positively promote and demonstrate Motorsport UK's Race with Respect Code which is appended to these Supplementary Regulations (Appendix C).

[21] Nomination of Drivers

Nomination of Drivers must be made at time of entry. A change of Driver is possible, with permission of the Clerk of the Course.

[22] Postponement/Cancellation

In the unfortunate situation of the cancellation of an event as a result of circumstances beyond our control, e.g. force majeure, viral pandemic, dictates from HM Government and/or Motorsport UK etc, we will propose returning event fees, less actual costs up to a maximum of £20.

[23] Officials

Officials of the Meeting will be listed in the Event Final Instructions issued for each individual event. Any changes will be published on the meeting notice board by the paddock office.

[24] Provisional Results

24.1. Provisional results will be displayed as per NCR Ch.3 App.6.

24.2. Provisional results will be published as soon as possible after the event on the Shelsley Walsh website.

[25] Results

25.1. Results will be determined by the Driver who has covered the Course in a lesser time, except for the Vintage Meeting where the results will be determined by the Driver against their handicap.

25.2. Championships will be run by the regulations issued for the individual championships.

25.3. Times recorded in a Championship Run-Off will only count for the absolute Best Time of Day Awards, not for any other Class awards within the event. If any non-registered competitor has qualified for an absolute Best Time of Day Award at the end of the Class runs, they will have the opportunity of becoming an additional runner in the Championship Run-Off and will be integrated into the order of running.

25.4. In the event of two competitors tying for an Award, the competitor with the lowest Aggregate times will be the winner. If the result is still a tie, the Stewards of the Meeting shall decide on a suitable solution.

25.5. All Class Awards will be presented at the end of the Meeting.

25.6. If the Award Winner is unable to collect their Award, someone may be nominated to collect it on their behalf.

25.7. Awards will not be posted out or held for collection at a later date.

[26] Protests

Protests must be logged in accordance with Ch.2 of the National Competition Rules.

[27] Parc Fermé

[28] Other Requirements/Information/GDPR Policy Reference

28.1. All other Motorsport UK General and Technical Regulations apply as written. All references are to the relevant version of the 2026 edition of the Motorsport UK National Competition Rules, at the time of the event.

28.2. Camping at Shelsley Walsh is permitted for Motor Homes, Caravans and Tents upon prior booking provided that they are parked in the Competitor's Car Park. There will be a charge of £15.00 per night. Competitors are asked to include the camping fee with their entry for each event. An inspection of passes will be made during the weekend. Anybody who has not **pre**-booked will be able to purchase their pass at the paddock office for £20 per night. Camping on Sunday night is **ONLY** permitted in the Orchard.

28.4. Animals are **NOT PERMITTED** in the Paddock, Main Car Park or Spectator Areas whilst practice or competition is taking place.

Notes:

- 2.1. Cars running in road going classes must compete in a road legal condition. Competitors must be able to produce proof of current road tax, insurance and MOT certificate. Proof of road tax will be via taxation receipt or vehicle enquiry printout using the DVLA enquiry website. Competitors will also be required to provide the vehicle registration number of the car on the entry form. Tyres must comply with List 1a or List 1b in the NCR Ch.8 App. 4.
- 2.2. Electric Vehicles: No vehicle will be permitted to compete unless the Emergency Response Guide (ERG) is provided in advance to the specific event organisers, as per NCR Ch.7 App.11 Art.3.5.
- 2.3. Competitors are reminded of the requirement for EVs to possess a Motorsport UK Vehicle Passport, as per NCR Ch.7 App.11 Art.1.16. Hybrid vehicles are not permitted in this class. No recharging will be allowed at the venue nor will any facilities to do so be provided.
- 2.4. All Caterham, Lotus Seven, Westfield and other 'Kit' cars complying with NCR Ch.14 App.4 will enter classes B and D. All other cars of this type which do not comply with the above will enter class F or G and comply with the relevant safety regulations.
- 2.5. Sports Libre — Saloon and Sports Cars. This class will include models originally built with 2 seats, either 2 or 4-wheel drive and any engine capacity as defined in the NCRs, except that all cars must have an integral non-detachable roof. Rally Cars competing in this class do not have to comply with NCR Chapter 13 but with Chapter 14 - Hillclimb and Sprint Sports Libre Cars. Entrants in this class need to have a competition licence that complies with NCR Ch.14 App.4 Art 1.4. This class is intended to include cars that do not comply with NCR Ch.14 App.2 Art.1.7; i.e. R5 cars such as Ford Fiestas and Skoda Fabias and modified Ford Escorts, including those cars with non-original manufacturer engines that would presently have to run in the current Sports Libre classes.
- 2.6. Vehicles competing in class J1 must comply with the appropriate NCR Formula Regulations.
- 2.7. To be eligible for class M - Sports Racing Cars and Racing Cars manufactured up to 1971 inclusive, vehicles of monocoque construction and those with rear wings will be allowed, provided they were standard on the car at the appropriate date. Wheel rim widths may be increased by no more than 25mm, but period style must be retained. The use of slick tyres is prohibited in class M. The type, size and tread of tyre must remain the same throughout the meeting. Post 1945 cars must run on treaded tyres which may be road tyres complying with the Motor Vehicles (Construction and Use) Regulations or racing tyres as long as the latter have grooves in the tread pattern which must be lateral and circumferential and any 40mm. diameter area of the tyre must have grooves in at least two different directions, which themselves must have a minimum width of 3mm.
- 2.8. All competing cars must comply with the safety requirements detailed in the 2026 Motorsport UK National Competition Rules and the relevant Championship Regulations.
- 2.9. All competing cars must comply with all the safety requirements detailed in the 2026 Motorsport UK National Competition Rules and these Regulations.
